Applications are hereby called from experienced Advocates as per prescribed format enclosed herewith as **Annexure-A**, for preparing a panel of 35 (28 Nos. + 7 Nos. anticipated vacancy) candidates, for appointment as Members of Foreigners Tribunals of Assam, on contractual basis. The number of vacancies may increase or decrease in near future.

### 1. Qualification of the candidate:

- (i) Should be a citizen of India.
- (ii) Any practising Advocate who has completed 45 years of age as on 1-6-2017 and 10 years of legal practice can apply for the post.
- (iii) The candidates will have to have fair knowledge of official language of Assam and its (Assam) historical background giving rise to foreigner's issues.

### 2. Tenure of the members:

- (i) Appointment of Lawyers as Member of the Tribunal will be purely on contractual basis for 2 years or as extended from time to time on need and performance basis. The candidate will be allowed to work/serve up to 60(sixty) years of age, if extension of service is allowed. Extension of service will be subject to approval by the High Court.
- (ii) The tenure of the Members so selected will be subject to their performance, suitability, continued utility and time to time assessment done by the Gauhati High Court.

#### 3. HOW TO APPLY:

- (i) Applicants are first required to go to the website www.ghconline.gov.in., download and take printout of the "Advertisement & Application Form". Applicants are advised to go through the advertisement carefully before filling up the form.
- (ii) Applicant shall fill the Application Form and paste his/her recent passport sized coloured photograph in the given space of the application form and shall sign across the photograph. Four copies of the same photograph should be stapled in the top right corner of the application form and the candidate should write his/her name on the reverse of the stapled photographs. The envelope containing the application form should be super scribed as "APPLICATION FOR THE POST OF MEMBER, FOREIGNER'S TRIBUNAL" and the same should be addressed to "The Joint Registrar (Recruitment),

- (iii) The envelope containing the application form along with other relevant documents should be dropped on or before 07/07/2017, during office hours, in the DROP BOX labelled as "DROP BOX OF APPLICATION FOR THE POSTS OF MEMBER, FOREIGNER'S TRIBUNAL, ASSAM" kept in the Recruitment Cell of the Gauhati High Court, Old Block at 1st Floor.
- (iv) Applications can also be sent to the above address by post, which should reach the given address on or before the last date (07/07/2017, during office hour) of submitting application. Applications received after the last date will be summarily rejected. The High Court shall not be liable for any postal delays.
- (v) Applications submitted in any other mode, except as indicated, will be summarily rejected without any communication.
- (vi) The list of the candidates, with allotted Roll Nos. will be published in the official High Court website for reference of the candidates in due course.

## 4. **SELECTION PROCESS**:

Selection process will be notified in due course.

## 5. TERMS AND CONDITIONS:

- *i.* The pay and allowance to the Members will be regulated as per Government decision
- Merely satisfying the eligibility criteria does not entitle an applicant to be called for the written examination/interview etc.
- No person, who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts.
- The admission of candidates at all stages of the selection process will be purely provisional and subject to their satisfying the prescribed eligibility criteria. If, on verification at any time before or after the selection process, it is found that a candidate does not fulfil any of the eligibility conditions, his/her candidature shall stand cancelled without any notice. Mere calling of candidate to written test / interview etc. or issuance of admit card / call letter etc. does not necessarily mean acceptance of candidature of any candidate, which shall, be further scrutinized at every stage and the High Court reserves the right to reject the candidature of any candidate at any time.
- Submission of application does not imply that a candidate has fulfilled all the criteria given in the advertisement and application is subject to subsequent scrutiny and the application can be rejected at any subsequent point of time, if any ineligibility condition is detected at any point of time.



- Vi. The list of the candidates, with allotted Roll Nos. will be published in the High Court website for the candidates' reference.
- **vii.** No TA/DA shall be paid to the candidates for appearing in the written test/interview etc.
- viii. The High Court may decide not to issue any admit card/call letter etc. to any candidate and may decide to call candidates to written examination/interview etc. by publishing a notification in the official website and notice board of the High Court. Candidates are advised to visit the official website (www.ghconline.gov.in) of the High Court regularly for updates and important information. Unnecessary correspondence should be avoided.
- Application form, which is incomplete in any respect, such as without the photograph, signature etc. is liable to be rejected summarily, unless otherwise decided by the High Court.
- **x.** Any information submitted by an applicant in his/her application will bind the candidate personally.
- **Xi.** The candidate will be responsible for any mistake made by him/her in the application form and the High Court shall not be responsible or liable in any way.
- xii. An applicant is allowed to submit one application form.
- The appointment and conditions of service of the selected candidates shall be governed by the Rules/ notifications so notified by Government of Assam.
- xiv. If any candidate is found canvassing directly or indirectly, his/her candidature will be rejected.
- The High Court reserves the right to cancel the advertisement, alter any terms and conditions of the advertisement, at any stage.
- The examination materials will be destroyed, due to scarcity of space, after six months of publication of the final select list, unless otherwise decided by the High Court.
- **XVII.** All other matters which are not specifically provided in this advertisement shall be as decided by the High Court.
