3. **Installation of Very High Frequency Station in the Court Complex, Barpeta.**


The Very High Frequency Station is not yet installed.


4. **Regarding status of Criminal Cases pending against sitting M.P. And M.L.A. in the District.**


The Public Prosecutor, Barpeta has informed that at Present there is no Criminal cases pending against any sitting M.P. or M.L.A.


