1. Regarding full name, address and mobile number of the Medical Officer and Investigating Officers in the Charge-sheet.

The matter is discussed by the members of the committee present. The Addl. S.P. (H.Q.), Barpeta has submitted a list of charge sheet wherein the full names and mobile numbers of the Investigating Officers are inserted but in some charge sheets, the I/O. fails to insert the full name and mobile number of the Medical Officers.

The Superintendent of Police, Baksa has informed that they have already submitted the list of cases with the full name and address of the I/O before the District & Sessions Judge, Nalbari. He has submitted a list to-day

also. But in the list the naame, adress and mobile number of the Medical Officers are not given.

The Deputy Superintendent of the FAAMCH has informed that in the casualty department mainly the P.G. Students examine the injured. After completion of their course they left the hospital. But their whereabout is not known to them. It creats a great problem in the medical department.

The Joint Director of Health Service, Barpeta has informed many times the medical officers put their short signatures in the medical report and then it creats problem in identifying the signature.

However both of them have assured that they will try to give the full name and mobile number of the medical officers.

The meeting has resolved that the medical administration will make a system to furnish medical report to avoid the problems face by them. The Investigating officer will approach the Superintendent of FAAMCH, Barpeta and Joint Director of Health Service, Barpeta for medical report and they will furnish the same callecting in proper channel by giving full name, address and mobile number of the medical officer.

The S.P., Baksa and the Addl. S.P. (H.Q.), Barpeta will furnish copy of list of cases wherein the name, address and mobile number of the medical officers are not given to the Superintendent of FAAMCH and the Joint Director, Health Service. Barpeta.

2. Uploading of database of the Medical Officer and Investigating Officer in the website of District and Police Administration.

Sri Pulak Patgiri, A.D.C., Barpeta has assured that he will discuss the matter with the Deputy Commissioner, Barpeta and will short the process of uploading the database of Medical Officers in the website of District Administration.

Addl. S.P. (H.Q.), Barpeta has informed that they have no separate website. Their website is controlled centrally by A.P.H.Q,Ulubari,Guwahati

3. Regarding Investigation of Cases.

The Addl. Sessions Judge and Asstt. Sessions Judge, Barpeta have already given the number of cases wherein the summons on the I/O. and M/O. are not served. The Addl. C.J.M., Barpeta has given a list of cases wherein the summons on the accused are not served. The Addl. C.J.M., Barpeta has placed a letter issued by Asstt. Inspector General of Police ® Assam, Guwahati to the S.P., Barpeta requesting him to execute the W/A. issued against accused Chan Mamud.

All those particulars are furnished to Addl. S.P. (H.Q.), Barpeta and he assures that he will look in to the matter.

In respect to the resolution taken on the last meeting, the meeting has resolved that if any Investigating officer make any prayer to change the teritorial jurisdiction of the case then it will be filled through the Addl. S.P. (H.Q.), Barpeta.

4. Installation of Very High Frequency Station in the Court Complex, Barpeta.

The Very High Frequency Station is not yet installed.

5. Regarding status of Criminal Cases pending against sitting M.P. And M.L.A. in the District.

The Public Prosecutor, Barpeta has informed that at Present there is no Criminal cases pending against any sitting M.P. or M.L.A.
