The Public Prosecutor has further stated that POCSO Act is a special Act and there are some differences in the procedure of investigation of the cases of POCSO


Act with the cases of there Acts.

Due to lack of knowledge of the I/O. They are committing wrong in the investigation of the cases under the POCSO Act.



The Public Prosecutor, Barpeta has informed that at present there is no Criminal cases pending against any M.P. or M.L.A.




