
Respected Sir,



Report in terms of the resolutions of the 1st and 2nd Zonal Administrative conference of the District Judiciary, District and Police administration of the lower Assam division and Cachar point wise.

1. With regard to point no. 1, I am to inform you that as per the information furnished to us, instructions have been duly given by the District Police Administration vide Memo No. S/No.BPTA/V/16/4290 dated 04-10-2016 to the IO's concerned with respect to the furnishing of the full name and address of the Investigating Officers as well as Medical Officers along with their mobile numbers in the Charge Sheet. In so far as the data of the investigating officers are concerned, almost 60% data with mobile numbers have been received but so far as the medical officers are concerned the response received in this regard is not up to the desired level. Nevertheless, the Police Administration is trying their best to collect/ furnish the aforesaid information as is being informed to us.
2. So far as point no. 2 is concerned, the website of the Barpeta District Police Administration is reportedly being maintained centrally at Guwahati but the data is not yet uploaded in the Website. So far as the District Administration is concerned, it is informed that they are working to upload the data of the medical officers in the Website and has informed that they are expecting to complete the work of uploading the data of the medical officers within 20 days.
3. Regarding point no. 3 the minutes of the District level monitoring committee meeting are being uploaded in the website of District Judiciary, Barpeta.
4. Regarding point no. 4 the disposal of Narcotic Drugs and Psychotropic Substance has been done in the presence of the then Sub Divisional Judicial Magistrate Md. Farhan Uddin Choudhury on 16-02-2017. However no subsequent prayer has been made in this regard.
